ARTICLE I

I direct that my just debts, my funeral expenses (including the cost of a suitable monument at my grave) and the costs of administration of my estate be paid out of the assets of my estate as soon as practicable after my death.

ARTICLE II

I bequeath and devise to my spouse, if my spouse shall survive me, all my estate and property, be that real, personal, or mixed (including, but not being limited to, my jewelry, wearing apparel, entire personal effects, all intangibles and all tangible personal property including motor vehicles owned by me at the time of my death, stocks, securities, choses in action, cash on savings or deposits on hand and remaining after proper administration of my estate, and whatever other realty and personalty I own
